What Information Does Exorium Collect?

We collect information from you when you register on our promotion site and gather data when you participate in our forums by reading, writing and evaluating the content shared.

When registering on our site, you may be asked to enter your name, email address and other related details. You will not be asked for your address, phone number or bank/credit card information at any stage so the information you will be submitted to us is more for logging in purposes.

You may however, visit our site without registering. We will send you an email containing your login details and associated login link once you register. It is imperative that you do not share your details with another person to ensure maximum privacy and protection of your data.

When registered and posting on our forum and other supporting sites, we record the IP address that the content originated from. We also may retain server logs which include the IP address of every request to our server.

What Do We Use Your Information For?

Any of the information we collect from you may be used in one of the following ways:

- **To personalize your experience** – your information helps us to better respond to your individual needs.
- **To improve our site** – we continually strive to improve our site offerings based on the information and feedback we receive from you.
- **To improve our service** – the information you provide us will assist us to more effectively respond to your needs.
- **To improve our site** – we continually strive to improve our site offerings based on the information and feedback we receive from you.
- **To send periodic emails** – the email address you provide may be used to send you information, notifications that you request about changes to topics or in response to your user name, respond to inquiries, and/or other requests or questions.

How Do We Protect Your Information?

We implement a variety of security measures to maintain the safety of your personal information when you enter and submit or access your personal information.

What Is Your Data Retention Policy?

We will make a good faith effort to:

- Retain server logs containing the IP address of all requests to this server for no more than 90 days unless otherwise lawfully needed
- Retain the IP addresses associated with registered users and their posts for no more than 5 days unless otherwise lawfully needed

Do We Use Cookies?

Yes. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your web browser (if you allow). These cookies enable the site to recognize your browser and, if you have a registered account, associate it with your registered account.

We use cookies to understand and save your preferences for future based visits and compile aggregate data about site traffic and site interaction so that we can offer better site experiences and tools well into the future. We may contract with third-party service providers to assist us in better understanding our site visitors. These service providers are not permitted to use the information collected on our behalf except to help us conduct and improve our business.

Disclosure for Outside Third Parties

We do not sell, trade or otherwise transfer your personally identifiable information to parties outside Exorium and you. This in no way includes trusted third parties who assist us in operating our site, conducting our business, or servicing you, so long as those parties agree to retain this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety.

However, non-personally identifiable visitor information sometimes may be provided to other parties for marketing, advertising or other uses.

Third Party Links

We use third party sites to help our users fully complete and engage with our website business. Other than that we will not use third-party sites for any reason.

Children's Online Privacy

Our site, features and services are all directed to people who are at least 18 years old or older, the age of majority. This is to comply with all international laws and governing regulations. If you are under the age of majority, we ask that you do not use this site.
